DETAILED VACANCY CIRCULAR

Applications are invited from the eligible officials for filling up 15 (fifteen) posts of **Assistant Director(S& R)** Pay Band-3 Rs. 15600-39100 with Grade pay of Rs. 5400 (Pre- revised) in Storage and Research Division, Ministry of Consumer Affairs, Food and Public Distribution, Department of Food and Public Distribution, Krishi Bhawan, New Delhi by transfer on deputation including (short term contract) basis. Details of the post, eligibility conditions etc. are given in the **Annexure-I**.

2. Applications of only such officers/ candidates will be considered as are routed through proper channel and are accompanied by:-

(i) Bio-data (as per the proforma given in **Annexure-II**) – Certification part to be filled up and countersigned by the Employer/ Cadre Controlling Authority. Each page of the Bio-Data and all supporting documents to be attested by an officer not below the rank of Under Secretary.

(ii) Photocopies of APARs for the last five (5) years duly attested on each page by an officer not below the rank of Under Secretary.

3. Applications of suitable and eligible officers and who can be spared immediately in the event of selection may be sent directly to the Under Secretary (SRA), Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, (Room No. 291), Krishi Bhawan, New Delhi – 110 001 within a period of **60 days** from the date of publication of this advertisement in the Employment News.

4. Advance copies of applications or those received after the prescribed closing date or not accompanied by required certificates/ documents are liable to be rejected. **Unemployed and private candidates are not eligible; therefore, they need not apply.**

(iv) with eight years regular service in posts in the Pay Band -2(Rs. 9300-34800/-), Grade Pay of Rs.4200/-; and

b) Possessing the following educational qualifications and experience:

Essential: (i) Master's Degree in Entomology or Plant Pathology or Bio-Chemistry from a recognised University; or

Master's Degree in Agriculture with specialization in Entomology or Plant Pathology or Bio-Chemistry from a recognised University; or

Master's Degree in Zoology or Botany or Chemistry from a recognised University; and

(ii) Five years' experience in teaching or research or extension work, including aspects related to storage and preservation of foodgrains.

Note: The Departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

(Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Government shall ordinarily not exceed four

years. The maximum age limit for appointment by transfer on deputation (including short-term contract) shall not be exceeding 56 years, as on the closing date of the receipt of applications).

Duties of Assistant Director (S&R): The duties of the Assistant Directors (S&R) are inspections of Food Storage Depots, Procurement Centres, Railhead, Fair Price Shops and Rice Mills. He/She initiates spadework concerning complaints from concerned State Governments, rice millers and consumers, settles disputes between the State Governments and Food Corporation of India at the time of taking delivery of food grains stocks from FSDs and supervises the work of Technical Officers (S&R).

Place of posting: The place of posting will be S&R Division, Department of Food And Public Distribution but liable to be posted anywhere in India.

Information:

- a. The officer selected will have the option to draw his grade pay plus deputation (duty) allowances or to have his pay fixed in the time scale of the pay attached to this post in accordance with the DOPT's OM No. 2/29/91-Estt. (Pay-II) dated 5.1.1994, as amended from time to time.
