DETAILED VACANCY CIRCULAR

Applications are invited from the eligible officers for filling up two vacancies to the post of **Joint Director (Technical)**, a General Central Service, Group 'A' Gazetted, Non-Ministerial post in Level-12 of the Pay Matrix in the Directorate of Sugar & Vegetable Oils – an attached office of the Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, by Deputation (including short-term contract). Details of the post, eligibility conditions etc. are given in the **Annexure-I**.

2. Applications of only such officers/ candidates will be considered as are routed through proper channel and are accompanied by:-

(i) Bio-data (as per the proforma given in **Annexure-II**) – each page of the Bio-Data and all supporting documents to be attested by an officer not below the rank of Under Secretary and certified by the Employer/ Cadre Controlling Authority.

(ii) Photocopies of APARs for the last five (5) years duly attested on each page by an officer not below the rank of Under Secretary.

3. Applications of suitable and eligible officers and who can be spared immediately in the event of selection may be sent directly to the Under Secretary (SA), Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, (Room No. 291), Krishi Bhawan, New Delhi – 110 001 within a period of **60 days** from the date of publication of this advertisement in the Employment News.

Eligibility conditions for appointment on Deputation (including short-term contract) basis: Officers under the Central Government or State Governments or recognized Universities or Public Sector Undertakings or Autonomous or Statutory organizations or research institutions fully or substantially controlled by the Central or State Governments:-
 - (a)(i) holding analogous post on a regular basis in the parent cadre or department; or
 - (ii) with five years service in the grade rendered after appointment thereto on a regular basis in posts in level 11 (Rs. 67,700-2,08,700) in the pay matrix; and
 - (b) Possessing the following educational qualifications and experience:-
 - (i) Bachelor of Engineering or Bachelor of Technology in Oil Technology or Degree in Science with postgraduate Diploma in Sugar Technology from a recognized University or Institute; and
 - (ii) having five years Experience in sugar or edible oils sector in an institute or organization under the Central Government or State Governments or recognized Universities or Public Sector Undertakings or Statutory or autonomous Organisation or research Institutions fully or substantially controlled by the Central or State Governments.
- Note 1:** The Departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationists shall not be eligible for consideration for appointment by promotion.
- Note 2:** Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government shall ordinarily not exceed three years.
7. Place of Posting: The place of posting will be Directorate of Sugar & Vegetable Oils (located at Krishi Bhawan, New Delhi) but liable to be posted anywhere in India.
