**TERMS & CONDITIONS:**

1. The bids received after the specified date and time will not be accepted.
2. Incomplete bids or any alteration, amendments & addition to bid are not permitted and such bids are liable to be rejected.
3. Earnest Money Deposit (EMD) prescribed for each vehicle separately must accompany the bid in the form of Demand Draft in favour of the Pay and Accounts Officer, Department of Food and Public Distribution, New Delhi. Bids without EMD will be summarily rejected EMD in any other form will not be accepted.
4. The original Demand Draft containing the EMD furnished by all unsuccessful bidders will be returned to them without any interest on the same day after final outcome of the bidding is declared by the authorised committee.
5. The bidders should quote their unconditional rates for each vehicle individually as per the enclosed prescribed proforma. If any bidder is interested to quote his bid for more than one vehicle, he has to submit separate bid along with the EMD for each of them.
6. Bid will remain valid for a period of 3 months from the date of opening of bids. Bids with lesser validity period will be summarily rejected.
7. Sealed tenders superscribed "Tenders for unserviceable/condemned vehicles" addressed to the Officer-Incharge, IGMRI, F.S, PAU Campus, Ludhiana-141004 (Pb.) should be dropped personally in the Tender Box kept in this office or submitted by speed post so as to reach this office latest by 3PM on 07.09.2022. The bidder may remain present or nominate their representative in writing to participate the process of opening of the bids at the prescribed date and time.
8. The inspection of vehicles should be done carefully by the prospective bidders or their representatives in this office premises between 11AM to 5PM between 18.08.2022 to 06.09.2022 ( Except Sunday/Saturday & Holidays) and queries be raised to the concerned officer at the time of inspection. No further clarifications shall be given after the above inspection.
9. The vehicle (s) should be removed by the highest acceptable responsive bidder on "as is where is" basis within five days of receipt of order after depositing the full amount in this office in the form of Demand Draft in Favour of Pay and Accounts Officer, Department of Food and Public Distribution, New Delhi. Amount of EMD may be adjusted against the final payment on the request of the successful bidder or EMD shall be returned after the relevant vehicle is removed as per terms and conditions laid down. In case the bidder remains unable to deposit the balance amount of the vehicle and vehicle is not removed from the premises within the prescribed time, the EMD will be forfeited and any loss whatsoever occurring due to this will be recovered from the bidder. The disposed vehicle will be removed under the supervision of designated officer(s) of this office. No extension of time will be given under ordinary circumstances. Competent authority in this Department may however allow an extension upto another 2 days provided full reasons for causing such delay is given in writing by the bidder. Delay beyond the stipulated time, may entitle this office to cancel the award/order and forfeit the EMD of the bidder without any intimation.
10. Vehicles will be allowed to be removed only during working hours. The vehicles will not be allowed to be removed on holidays or after working hours.

11. No damage should be caused to the existing property of the Institute or the Govt. while removing the disposed vehicle from the site. Any loss/damage to the Govt./Institute or injury or personal accident suffered by any person due to the negligence or action of the successful bidder or his authorised representatives shall be recovered from the concerned bidder/allottee.
12. Bidder must enclose self attested copy of address proof ( voter I-card,/AADHAR Card/Driving Licence etc and PAN card alongwith his bid.
13. This Department reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever.
