Export Release Order for Exporter

Whereas, DFPD vide letters of even number dated 05.06.2022 and 06.06.2022 has issued combined export release orders to exporters and sugar mills respectively.

2. Whereas, one representation received through email from Royal Government of Bhutan (RGoB) for continuation of export of sugar to Bhutan has been examined. It is mentioned that Bhutan's requirement of sugar is 10,000 MT (until 31st October, 2022).

3. Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in exercise of powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, permission is granted to following exporters to export a total quantity of **10,000 MT (Ten Thousand only)** of sugar within 90 days from the date of this order:-
