DETAILED VACANCY CIRCULAR

Applications are invited from the eligible officers for filling up one vacant post of **Assistant Professor (Organic Chemistry)**, a General Central Service, Group 'A' Gazetted, Non-Ministerial post in Level-11 of the Pay Matrix at National Sugar Institute, Kanpur – a subordinate office of the Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, by Composite Method: Promotion/ Deputation (including short-term contract).
