**DETAILED VACANCY CIRCULAR**

Applications are invited from the eligible officers for filling up the post of **Deputy Director (General Cadre)**, a General Central Service, Group 'A' Gazetted, Non-Ministerial post in Level-11 of the Pay Matrix in the Directorate of Sugar & Vegetable Oils – an attached office of the Department of Food & Public Distribution, Ministry of Consumer Affairs, Food & Public Distribution, by Composite Method [Deputation (including short-term contract) plus Promotion]. Details of the post, eligibility conditions etc. are given in the **Annexure-I**.

2. Applications of only such officers/ candidates will be considered as are routed through proper channel and are accompanied by:-

(i) Bio-data (as per the proforma given in **Annexure-II**) – each page of the Bio-Data and all supporting documents to be attested by an officer not below the rank of Under Secretary and certified by the Employer/ Cadre Controlling Authority.

(ii) Photocopies of APARs for the last five (5) years duly attested on each page by an officer not below the rank of Under Secretary.

3.     - (i) Bachelor's Degree in any discipline from a recognized University or Institute; and
    - (ii) Five years experience in dealing with sugar or food control and sugar trade especially in respect of marketing, movement and grading of sugar, in a sugar industry or Government Organization.

**Note 1:** The Departmental Assistant Director (General Cadre) in Level-10 (Rs. 56,100-1,77,500) in the Pay Matrix with five years regular service in the grade (and possessing the requisite qualification and experience as prescribed for considering appointment on deputation basis) shall also be considered alongwith outsiders and in case of his selection to the post, it shall be treated as promotion.

**Note 2:** The Departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

(Period of Deputation (including short-term contract) including the period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not to exceed four years).
