Export Release Order

Subject: Combined Export Release Order for sugar mills whose exporter has opened valid Irrevocable Letter of Credit (LC) prior to notification of export restrictions.

Whereas, DGFT vide notification dated 24.05.2022 has placed Sugar (Raw sugar, Refined sugar & White sugar) bearing ITC (HS) Code 17011490 & 17019990 in "Restricted" category for exports. Further, DFPD vide letters of even number dated 24.05.2022 has issued letters to sugar mills as well as exporters along with the guidelines/procedure for applying/obtaining Export Release Order (ERO) for sugar mills and exporters.

2. Whereas, DFPD vide letters dated 05.06.2022 and 06.06.2022 combined export release orders to exporters and sugar mills have been issued.

3. Whereas, some sugar mills have signed contract for export of sugar with exporters who have valid Irrevocable Letter of Credit (LC) opened prior to notification of export restrictions i.e. on or before 23.05.2022. ERO is issued to one sugar mill whose exporter has opened valid Irrevocable Letter of Credit (LC).

4. Therefore, Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in exercise of powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, hereby, grant permission to M/s. Daurala Sugar Works, Daurala/2901 sugar mills to export sugar for a quantity of 6180 MT up to 31.10.2022 to fulfill obligations under the Irrevocable LC **(LC No. SGAX312-207360) opened by the exporter i.e. Louis Dreyfus Company India Private Limited (IEC No. 397061340).**

5. The custom authorities may allow export of sugar by the sugar mill/exporter up to the quantity mentioned above after verifying the following documents:

a. ERO of the sugar mill.



- b. Factory invoice after the date of this ERO confirming the quantity of sugar lifted from the sugar mill to which ERO has been issued.
- c. Validity of LC mentioned in Para 4 above.

6. The Sugar mill shall submit a report of implementation of Release Order after completion of such export to the Director (Sugar).
