**Export Release Order for Pharma Sugar**

**Subject:** Combined Export Release Order for exporters which have procured pharma sugar for export purpose.

Whereas, DGFT vide notification dated 24.05.2022 has placed Sugar (Raw sugar, Refined sugar & White sugar) bearing ITC (HS) Code 17011490 & 17019990 in "Restricted" category for exports. Further, DFPD vide letters of even number dated 24.05.2022 has issued letters to sugar mills as well as exporters along with the guidelines/procedure for applying/obtaining Export Release Order (ERO) for sugar mills and exporters.

2. Whereas, DFPD has issued Export Release Orders (EROs) to exporters and sugar mills vide letters of even No. on various dates, uploaded on DFPD website i.e. <https://dfpd.gov.in/index.htm>.

3. Whereas, some exporters have already contracted for export of pharma sugar and are unable to export due to restrictions. Therefore, in order to address the problems faced by such exporters, it has been decided to issue EROs in such cases.

4. Therefore, Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in exercise of powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, hereby, grant permission to such exporters to export pharma sugar by 31.10.2022 as mentioned in the **Annexure**.

5. The exporter shall submit a report on implementation of Release Order through email.
