**Export Release Order for Sugar Mills for Raw Sugar**

**Subject:** Combined Export Release Order for sugar mills where sugar mills are having stock of raw sugar and have requested for Export Release Order.

Whereas, DGFT vide notification dated 24.05.2022 has placed Sugar (Raw sugar, Refined sugar & White sugar) bearing ITC (HS) Code 17011490 & 17019990 in "Restricted" category for exports. Further, DFPD vide letters of even number dated 24.05.2022 has issued letters to sugar mills as well as exporters along with the guidelines/procedure for applying/obtaining Export Release Order (ERO) for sugar mills and exporters.

2. Whereas, DFPD has issued Export Release Orders (EROs) to exporters and sugar mills vide letters of even No. on various dates, uploaded on DFPD website i.e. <https://dfpd.gov.in/index.htm>.

3. Whereas, advisory was issued vide letter dated 25.08.2022 to all the sugar mills that in case any sugar mill still has raw sugar available with them and intend to export such raw sugar then such mills can submit their request for issuance of EROs to Directorate of Sugar. Applications have been received from the sugar mills as per Annexure which have produced raw sugar for export purpose and are unable to export due to restrictions, it has been decided to issue EROs to these sugar mills having stock of raw sugar and have requested for ERO.

4. Such sugar mills can export the allocated quantity of raw sugar themselves or through exporters for which no separate EROs will be issued to exporters. The custom authorities may allow export of raw sugar by the sugar mill/exporter up to the quantity as per the Annexure after verifying the following documents:

- a) ERO of the sugar mill.
- b) Factory invoice after the date of this ERO confirming the quantity of raw sugar lifted from the sugar mill to which ERO has been issued.

5. Therefore, Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in exercise of powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, hereby, grant

permission to sugar mills to export raw sugar directly by them or through their exporters by 31.10.2022 as mentioned in the **Annexure**.

6. Since, raw sugar is either directly exported or after value addition of such raw sugar by refinery it is exported in the form of refined sugar. Therefore, customs authorities may allow exports of raw sugar or refined sugar manufactured from such raw sugar by the refinery/ sugar mill/exporter. Such refinery/sugar mills which have procured raw sugar from the sugar mill within the quantity mentioned against the name of the raw sugar manufacturer as per Annexure are allowed to export refined sugar on producing relevant contract and invoice between the raw sugar manufacturers and refined sugar manufacturers.

7. The sugar mill shall submit a monthly report on status of implementation of ERO through email.
