Export Release Order-1

Subject: Combined Export Release Order for sugar mills where sugar mills are having stock of raw sugar as per online P-II and have requested /applied for Export Release Order.

Whereas, DGFT vide notification dated 24.05.2022 has placed Sugar (Raw sugar, Refined sugar & White sugar) bearing ITC (HS) Code 17011490 & 17019990 in "Restricted" category for exports. Further, DFPD vide letters of even number dated 24.05.2022 has issued letters to sugar mills as well as exporters along with the guidelines/procedure for applying/obtaining Export Release Order (ERO) for sugar mills and exporters.

2. Whereas, DFPD vide letters dated 05.06.2022 and 06.06.2022 combined export release orders to exporters and sugar mills have been issued.

3. Whereas, many sugar mills which have produced raw sugar for export purpose are unable to export due to restrictions. Since the raw sugar if not exported or used may get deteriorated in other 3-4 months time, it has been decided to issue EROs to such sugar mills having stock of raw sugar and have requested /applied for Export Release Order.

4. Such sugar mills can export the allocated quantity of raw sugar themselves or through exporters for which no separate EROs will be issued to exporters. The custom authorities may allow export of raw sugar by the sugar mill/exporter upto the quantity as per the Annexure after verifying the following documents:-

- i. ERO of the sugar mill.
- ii. Factory invoice confirming the quantity of raw sugar lifted from the sugar mill to which ERO has been issued.



5. Therefore, Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in exercise of powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, hereby, grant permission to sugar mills to export raw sugar directly by them or through their exporters by 31.10.2022 as mentioned in the **Annexure**.

6. The sugar mill shall submit a monthly report on status of implementation of ERO through email.
