**Export Release Order for Sugar Mill**

Whereas, DFPD vide letters of even number dated 05.06.2022 and 06.06.2022 has issued combined export release orders to exporters and sugar mills respectively.

2. Whereas, Directorate of Sugar and Vegetable Oils vide order dated 08.07.2022 issued ERO to M/s Bannari Amman Sugars Limited, 64101/ TIRUVANNAMALAI sugar mill to dispatch a total quantity of 3730 MT (Three Thousand Seven Hundred and Thirty only) through M/s Hari & Co. International LLP (exporter) within 30 days for export to Maldives to supply to State Trading Organization (STO), a state owned enterprise of the Government of Maldives.

3. Now, representation has been received from M/s Hari & Co. International LLP for extension for lifting of the balance quantity of 2950 MT from the manufacturer i.e. M/s Bannari Amman Sugars Limited, 64101/ TIRUVANNAMALAI sugar mill.

4. Directorate of Sugar and Vegetable Oils, Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, in exercise of powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with clause 4 and 5 of the Sugar (Control) Order, 1966, permission is granted to **Bannari Amman Sugars Limited, 64101 / TIRUVANNAMALAI** to dispatch/lift balance quantity of **2950 MT (Two Thousand Nine Hundred Fifty metric tons only)** of sugar to M/s Hari & Co. International LLP by 31.10.2022 for export to Maldives to supply to State Trading Organization (STO), a state owned enterprise of the Government of Maldives.

4. All other conditions of the combined export release order issued on 06.06.2022 will remain same.
