<u>Minutes of the meeting of the Screening Committee under Sugar Development</u> <u>Fund (SDF) held on 04.10.2019</u>

A meeting of the Screening Committee for consideration of the loan applications for Sugar Cane Development under Sugar Development Fund (SDF) was held under the Chairmanship of Joint Secretary (S&A) on 04.10.2019 at 03.30 P.M. Room No 167, First Floor, Krishi Bhawan, New Delhi. List of Members, Special Invitees and Sugar Factory representatives who attended the meeting is at Annexure-I.

2. At the outset, the Chairman welcomed all the Members of the Screening Committee. After that, the agenda items were taken up for discussion. The observations/recommendations are as follows:

Agenda Item No: 1

M/s Nirani Sugars Limited, 166, Kulali Cross, Jamakhandi Road, Mudhol Taluk, Bagalkot, Karnataka – 587313 has submitted a proposal for SDF loan for Cane development involving SDF assistance of Rs.540.00 lakh.

The application was recommended and forwarded by the State Government of Karnataka.

The application was considered earlier by the Screening Committee in its meeting held on 06.06.2019. The Committee deferred the proposal as the Sugar Factory has not furnished the baseline information for 'Expected benefits on completion of the project.'

Now the proposal has been considered in the Screening Committee meeting held on 04.10.2019. The Sugar Factory has applied for an SDF loan of ₹540.00 lakh for the following schemes:

Minutes of the Screening Committee meeting held on 04.10.2019

The information on Expected benefits on completion of the project and variety of seeds proposed to be cultivated under the Cane Development project submitted by the Sugar Factory has been perused by the Committee. Director NSI, Kanpur observed that the Sugar Factory has not furnished the details of 'area of cultivation of proposed varieties' and 'physical performance target and deliverables.' The Committee directed to obtain the same from the Sugar Factory.

As on 31.03.2018 based on ABS 2017-18, the DSCR of the sugar factory and company as a whole is 0.48, FACR of the sugar factory and company as a whole is 1.40, and IRR for the project is 12%.

Further, representative of the Sugar Factory informed the Committee that they have repaid the pending SDF Dues. The same was also reiterated by the IFCI. The Committee directed to confirm the payment status from the O/o CCA. The proposal will be placed before the Standing Committee after the receipt of the confirmation from the O/o CCA.

Subject to above, the Screening Committee, on the basis of the recommendation of State Government, technical and financial details, and eligible project cost recommended SDF loan of ₹236.25 lakh for 1st year and ₹303.75 lakh for 2nd year for consideration of the Standing Committee.

Additional Agenda Item No: 2

M/s Sahakar Shiromani Vasantrao Kale Sahakari Sakhar Karkhana Ltd., At-Post-Bhalawani, Taluka Pandharpur, Maharashtra has submitted a proposal for SDF loan for Cane development involving SDF assistance of Rs.540.00 lakh.

The application was recommended and forwarded by the State Government of Maharashtra.

The application was considered earlier by the Screening Committee in its meeting held on 06.06.2019. The Committee observed that the Sugar Factory is incurring losses during the last five financial years. Also, the DSCR of the Sugar Factory and Company as a whole for the FY 2017-L9 is 0.08. Therefore, the Committee deferred the proposal with directions to re-examine the financials of the Sugar Factory.

Now the proposal has been considered in the Screening Committee meeting held on 04.10.2019. The Committee has observed that SDF dues of \gtrless 2,84,51,556.00 is outstanding against the Sugar Factory as per O/o CÇA's letter dated 19.09.2019. The Sugar Factory has been requested to clear the dues and to furnish No Dues Certificate from the O/o CCA vide this Departments letter dated 27.09.2016.

Keeping in view of the outstanding SDF Dues, the Committee deferred the proposal.
